I have the honour to inform that the African-Asian Rural Development Organization (AARDO), in collaboration with the Park Chung Hee School of Policy and Saemaul, University of Yeungnam, Government of the Republic of Korea, is providing opportunities to promising young officials from member countries to pursue **Master's Degree Programme** (One and a half year/four semesters) at the *Department of Saemaul and International Development, Department of Public Policy and Leadership, Department of Sustainable Development* of the Park Chung Hee School of Policy and Saemaul, Yeungnam University.

Yeungnam University, located at Gyeongsan, is **one of the oldest and leading universities** in the Republic of Korea. The Park Chung Hee School of Policy and Saemaul (PSPS) of the University offer Master's Degree Programme in the following three disciplines:

- (1) **Saemaul and International Development;**
- (2) **Public Policy and Leadership; and**
- (3) **Forest and Environmental Policy.**

This Master's Degree Programme is aimed at providing students with a supportive environment **to create global leaders for playing a pivotal role in reducing poverty and working for the betterment of the world** for a scintillating future of the youth by nurturing them as leaders and change agents **to contribute towards rural transformation in African Asian countries.**

During the first three semesters, candidates will be required to remain on campus to complete their coursework. However, in the last semester, candidates may choose to prepare for their thesis either in Korea or in their respective home countries. In case the candidate needs to travel to R O Korea again, travel cost will have to be borne by the candidate or nominating Government/Institutions.

It is hoped that the Master's Degree Programme being offered by Yeungnam University, will be found useful and the esteemed Government would encourage a suitable young Graduate official to pursue the Master's programme.

The candidate must satisfy the following:

- Completed 12 years of formal education covering elementary, middle, and high school (or its equivalent) prior to undergraduate studies.
- Obtained a bachelor's degree from a recognized institution, equivalent to a 4-year Korean bachelor's degree.
- Demonstrates a high level of proficiency in English.
- Must be in good health, suitable for completing the degree programme. (Please note that conditions such as pregnancy, tuberculosis, or any contagious diseases may disqualify an applicant from the selection process.)
- Must be below 50 (fifty) years of age.
- Must obtain travel and health insurance.

Hon'ble Minister will appreciate that this fellowship has expenditure inclusions and exclusions as highlighted in the following table:

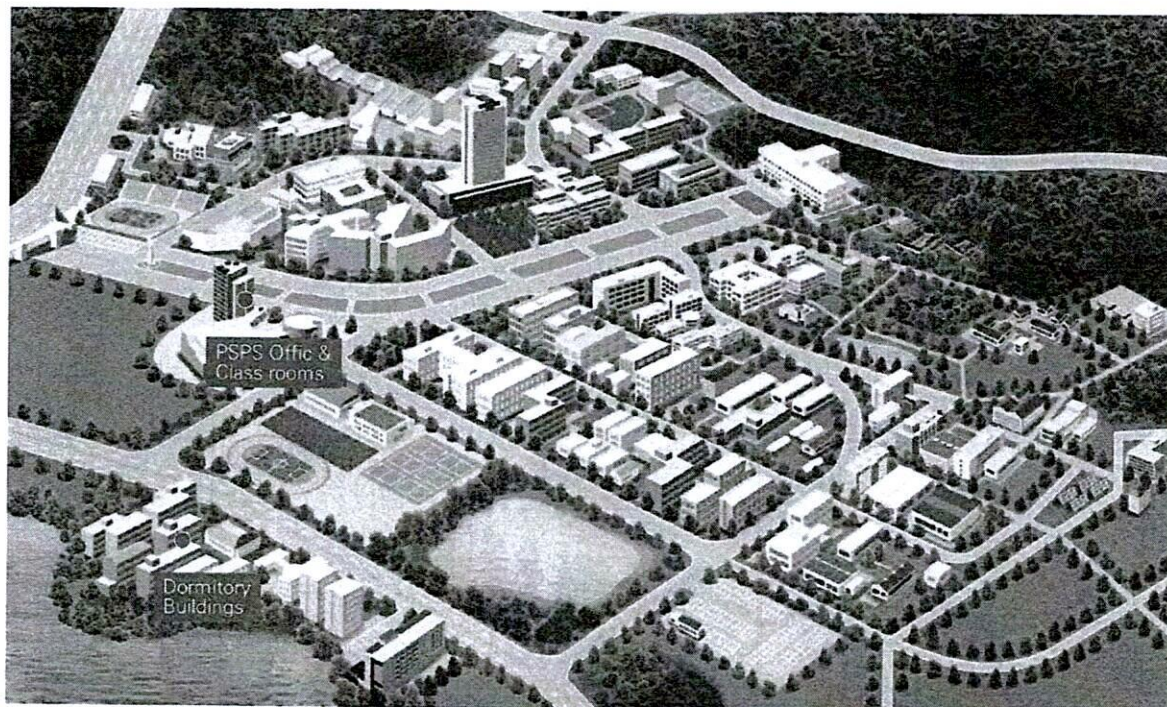
... Residency Requirement in Korea
